Mr. Packer,

We are disappointed in your response to our request for investigation of Sheriff Deputy Steiner's assault and battery of me at the end of day June 16, 2022. This is a serious matter, instigated by the Deputy, that if proven could appropriately result as we understand it, in a one-year suspension of duty of Deputy Steiner.

First, you conveniently claimed that the video surveillance cameras in lobby and clerk office were "not working" on the evening of June 16, 2022, when Sheriff Deputy Steiner assaulted and battered me, and hence could not provide our GRAMA requested footage. Do you realize how damning that "coincidence" is to your unbelievable claims?

Second, you and Mr. Mark Urry (GRAMA Officer) ignored and/or chose not to provide court house lobby GRAMA requested surveillance footage as requested on Sept 2, 2022 covering specific times during the week of our trial June 27 thru July 1, for some unexplained reason. (see GRAMA requested email of July 1, 2022 below) NOTICE: We still require of you / Mark Urry some sort of written and inksigned signature response that was due by September 16, 2022, to our lawful

GRAMA request, which currently remains in a state of self-serving non-response. That is illegal and unlawful.

Thirdly, it is indeed convenient that with your intimation that the video footage does not exist to prove my claim of being victimized by Deputy Steiner, now you can fabricate and *color* a portrayal of the events in manner designed to protect him from being held responsible for his actions.

Your "decision" to not hold Deputy Steiner (and the others in Email #2) is not acceptable, and is hereby **officially Rescinded and Rejected** for reasons of dishonor that include but are not limited to those provided herein. We reserve our rights to pursue and obtain remedy which may include personal liability for trespass and damaging actions outside of oath and the law.

Why all the hiding, if you honestly have nothing to hide? It is sad to Barbara and I to witness how you and others have apparently compromised your integrity in the promotion of knowingly less-than-100% accurate information, in an apparent effort to protect one of your fellow officers, in his violation of law, assault and battery, and in the trespass of my rights and privileges to free and unencumbered access to the court.

Additionally, you also conveniently claim the footage that would prove my charges does not exist, **thus failing to do your job to insure security to me** in a courthouse by properly and professionally maintaining surveillance footage for just such an occasion as this, and by extension **violating the trust of all of We the People** who pay you, and for whom you are supposed to work and serve.

Barbara & I (as a former elected Cedar Hills City Councilman), have long supported and defended law enforcement. But over the past many months now we have personally been endangered and victimized by approximately 100 so-called "law enforcement" officers that should have been our friends and defended our rights. We no longer wonder why the trust of the People and respect for those who are supposed to "Serve and Protect" — is failing. The existing "defund the police" chaos mentality and further chaos, may indeed be **self-inflicted**.

We would love to put you and others on the witness stand under oath, and cross-

examine in detail to determine if perjury would be committed there regarding your various claims. Maybe we will.

It is <u>not</u> an impossible situation for you and your fellow Deputies. A restoration of your honor is possible. You and your fellow officers are invited to reconsider becoming whistleblowers to the questionable "culture" allowed / promoted by you and your superiors, in behalf of your oath of office and *We the People* who pay your wages. Mr. Cromar

I have investigated your complaint against Deputy Jeff Steiner stemming from your interactions with him on June 16, 2022. I have read Deputy Steiner's report and interviewed him. I interviewed several other witnesses present in the courthouse that day. I reviewed the evidence available and have taken in the totality of the situation. With that being said, I am declining your complaint that Deputy Steiner tried to incite you and/or that he assaulted you.

I base my decision on witness testimony. Deputy Steiner was called to the clerk's office because of your demeanor. Deputy Steiner and the other witnesses present stated that you "slammed" or "pounded" your fists on the counter. After that occurred, Deputy Steiner told you it was time to leave. He then escorted you from the building. Your statement to me about this was, "That's a lie! No yelling, no screaming, no pounding."

According to witnesses, when Deputy Steiner was escorting you out of the building you were visibly upset and continued to want to argue. Deputy Steiner does admit to pointing his finger toward you and then pointing to the door, all while ordering you to leave the building. He admits to touching the back of your arm in an attempt to turn you toward the door to get you to leave as ordered. The actions he took were an attempt to get you to leave the building after you had already caused a disruption at the Clerk's counter.

One witness to your interaction with Deputy Steiner next to the exit door stated, "I

could not hear what was being said but Mr. Cromar's body language suggested to me that he was still emotional and upset as Officer Steiner talked with him." Another witness interacting with Deputy Steiner moments after the event described him as having a "calm demeanor."

I believe Deputy Steiner took actions consistent with getting you to leave the building. He finally had to warn you that if you did not leave you would be arrested for disorderly conduct. He acted legally as a Deputy attempting to get you to comply with his orders and simply leave the premise after you had already caused a disruption.

No charges will be filed on Deputy Steiner for Assault. In Utah code, Assault is described as attempt "to use unlawful force or violence to inflict bodily injury." Deputy Steiner's action was reasonable and there was no attempt to inflict bodily injury. His actions were well within Sheriff Office policy for dealing with an individual who was clearly upset and refusing to follow the lawful commands of a Deputy.
