Mr. Packer,

After reviewing your email below, we were disappointed to read your bifurcation of the facts, regarding the theft of our three lawfully filed documents at the Utah County Recorder's office March 30, 2022, and the refusal to hold the clerks accountable to Utah Code 57-3-104 - "Certified copies entitled to record in another county" - we are "ENTITLED" to do so. The law is clear. The County Recorder and/or certain clerks should have been arrested and/or been charged criminal, as we previously requested.

Our documents were not "abandoned" as you falsely claim. This is a lie. Rather we lawfully filed "on demand" as this video shows.

Also, please provide a hard copy response to this email with <u>your wet ink signature</u> to confirm that indeed you are the originator of the communication below, and mail it by separate envelope sent first class USPS mail to the address below.

Please note that this email is CC'd to our three Utah County Commissioners to alert them to your to failure to serve the People of Utah County in a 100% trustworthy manner, and is also shared publicly at <a href="https://www.CedarHillsCitizens.org">www.CedarHillsCitizens.org</a>.
