## **Declaration of Thomas H. Fairbanks**

Pursuant to 28 U.S.C Section 1746, I, Thomas H. Fairbanks, make the following declaration:

- 1. I am over the age of 21 years and I am under no legal disability, which would prevent me from giving this declaration.
- 2. I am in possession this day of the attached "Video, Victim and Witnesses" Statement delivered to me by a concerned citizen of Cache County Utah. By association and "first hand" disclosure I know of the stated meeting referenced in paragraph 6. I also know the identities of the "author," who is using the pseudonym "R. Smith" and the "victim" referred to as "XX" and her "new husband," as I was also physically present at the referenced meeting 5 ½ years ago and participated in the discussion concerning the court corruption in Cache County Utah.
- 3. I reside at 345 N 150 West in Logan, Utah 84321.
- 4. I was present when the "author" was explaining how she was aware of the "victim" and the story of the video tape and how it came to be. However, I was never told who the parties were who made the video tape.
- 5. I was also present as the "author" told of the contents of the video, which recorded in detail the ceremonial rape of the "victim" by the 8 men in black robes along with the stated identities of the 3 identified men in the Statement.
- 6. As previously stated I personally know the "victim" and her "new husband" and was personally told by them of the "victim's" rape experience, including the trip to the carpet store with her boy friend and her traumatized return home to her mother, prior to the referenced meeting 5 <sup>1</sup>/<sub>2</sub> years ago.
- 7. I personally collaborated with the "victim" and her "new husband" in obtaining information about satanic ritual abuse (SRA), public corruption and judicial and prosecutorial misconduct in the courts of Cache County.

- 8. As referenced in the Statement, the "victim's" first born son is in the Utah State Penitentiary serving time for child sexual assault. In December of 2015, the "new husband" personally showed me the envelope with a return address of the penitentiary at the point of the mountain in Draper, Utah and a warning letter written to his mother by the "victim's" first born son about his witnessing a similar rape experience of a young girl in Providence Canyon. His letter discussed similar details of the "victim's" abuse and named some of the same individuals in the video recording.
- 9. One might say that the collaborative discussions with the "victim" and her "new husband" resulted in my being taken down the rabbit hole and introduced me, as an outsider, to the cesspool of SRA and the public corruption that has a stranglehold upon the City of Logan and Cache County.
- 10. We met privately with numerous individuals who have been impacted by this evil and as a result I have access to a large amount of witnesses, stories and documents. It is a sad commentary to admit that Satanists have a strong hold in this community.
- 11. Our collective efforts resulted in the exposure of Public Corruption, Satanic Ritual Abuse Victims, and All Manner of Fraud Upon the Court and The People in Cache County Utah as (3) Friend of the Court Briefs were filed with the First District Court, Cache County Utah on December 14, 2015. (Case #151100492, #131101182, #141100257) Each of the briefs showed the return address of the "victim" and her "new husband."
- 12. The briefs also address a long chain of criminal behavior which reaches the level of RICO violations including satanic ritual assaults experienced here in northern Utah that also coincided with the 1990 Glenn L. Pace Memorandum to the LDS Church's Strengthening Church Members Committee about Ritualistic Child Abuse. Sadly, these activities continue to be a problem even to today.
- 13. Sometime ago I reached out to whistleblower Cathy O'Brien Phillips asking her if, Logan Utah was another Mena, Arkansas. Her story and the activities surrounding our

regional airport are eerily similar. A couple of years ago, I had a chance meeting with someone in the Operation Underground Railroad organization and was able to ask them to confirm a statement I had been told by someone who had worked with the organization. I was told that when it comes to sex trafficking here in the United States, that the spotlight was on the State of Utah, but when it comes to the State of Utah that the capital is right here in Logan/Cache County. In answer to my statement they asked, "Why are you still alive?" My reply was simply, "they have made many attempts."

- 14. As indicated in the attached Statement, these people would love to make these men pay for all of the years of torture they have endured and that their families have suffered. But these are very powerful men whom they are afraid of and would do anything to avoid their wrath.
- 15. In February of 2017, the "victim" and her "new husband" filed suit against me in Providence Justice Court, in part, to separate themselves from me and any connection they had with the Friend of the Court Briefs. It was obvious that the briefs were the central issue of their action and that the "victim" and her "new husband" and other interested/affected parties named in the Friend of the Court Briefs had a personal interest in discrediting me and the Friend of the Court Briefs. However, their legal action allowed me to update the Friend of the Court Briefs to specifically level a charge of judicial misconduct for those involved. The "victim" and her "new husband's" legal request was denied.
- 16. Following multiple threats (physically, verbally electronically, as well as the attempts on my life, which included being poisoned), I appealed to the Section Chief of Public Corruption and Special Prosecutions, Nate Mutter, with the Utah State Attorney General's Office. During my two hour conversation with him, I presented him with all of the documentation and even had him listen to the voicemail threats made against me.

- 17. The briefs also discuss the FBI investigated Public Corruption of a Cache County Prosecutor, George Daines, and his resignation from office in exchange for his nonprosecution involving his paying witnesses, with drugs, for their testimony against a pain clinic doctor, Ray Bedell, for the alleged sexual assault of the bought off witnesses. However, at the same time, Mr. Daines' family bank, Cache Valley Bank, was under investigation for insolvency by the Utah Department of Financial Institutions. Following Daines' resignation he traveled back to New York to visit his brother, Dr. Richard Daines and sister-in-law Linda, a managing director of Goldman Sachs, who is believed to work with the Royal House of Qatar. Upon Daines' return to Cache Valley his bank experienced a miraculous turn around and was in a position to buy up other failing banks, for pennies on the dollar, making Cache Valley Bank one of the largest local banks in the State of Utah.
- 18. There are responses in public records included in the briefs that show a connection to ISIS here in Cache County and the protection of the royal family from a sexual assault crime that was charged against another innocent party, even though DNA evidence was clearly not a match to the one charged and convicted of the crime.
- 19. During my discussion with Nate Mutter, he told me that he had formerly been a police officer with the Logan City Police Department. I then looked him right in the eye and said, "Then you know what I am talking about." <u>Sadly, about three weeks later, I received a voice message from Nate Mutter telling me that "it would be a conflict of interest for them to pursue my claims." REALLY? How does doing his job become a conflict of interest? Unless he/they are directly involved! Interesting admission, don't you think?</u>
- 20. I was then directed by Nate Mutter to take the matter to the FBI. Since I had already experienced the horrid behavior of the FBI (explained in the briefs), I chose to wait before deciding what to do. After John Huber was appointed by Jeff Sessions, I was hopeful that finally there was someone to whom I could appeal, and so I did to my detriment.

- 21. I am under Federal indictment by the office of "the human garbage disposal," John Huber, in the District of Utah where I had my first court appearance on December 5, 2019. I found myself in this position about six months after I appealed to US Attorney John Huber as a whistleblower seeking his assistance and protection. AND who is one of chief accusers? The "victim's new husband!"
- 22. Many have wondered how it is that an allegation, which should have been charged in the district court, has managed to find its way past the state courts into the federal court system and that I find myself in company with the likes of Lt. General Flynn, Rick Gates, Paul Manafort, George Papadopoulos, and Roger Stone; whose stories all have a familiar ring.
- 23. A personal friend of mine has been repeatedly told by the "victim's new husband" that I have pissed off some very powerful people who want me destroyed. For a long time I just thought my situation was the result of local political influence seeking my destruction? That is until; I discovered a few months ago that Huber had actually reported his findings in January 2020. Boy was I shocked to learn that Huber claimed that there was nothing to be found and I chuckled when President Trump called him a "human garbage disposal." A more fitting description does not exist.
- 24. It was then I realized that my situation might be personal to John Huber as well, the man who said there is nothing to see. In December of 2017, I was divinely directed to go home and write a book titled, *American Crossroad of Trust*, which was published by Amazon on January 18, 2018. The book I believe details the current condition we are experiencing here in America and a good portion addresses many of the matters that have come from the Clinton's and their cartel. In the first edition the last chapter makes the connection to the Bundy mistrial, the John Podesta emails and National Monuments, which points directly to uranium and Hillary Clinton's actions that resulted in the selling 20% of our Uranium deposit to an enemy of the State (all from public records). I was later prompted to add an additional chapter in the second edition to include the Russia Collusion Hoax and the story of Hillary Clinton's interview with

Matt Lauer, which ends with Hillary's tirade in which she states that if Trump is elected they will all hang!

- 25. So is this personal to John Huber? Everything he was assigned to investigate was exposed and published long before he reported there was nothing to see. AND then I asked for his help as a whistleblower. Surely this is more than a coincidence!
- 26.I believe you can see my dilemma and I am asking for help. We have exposed the cesspool and in fear the victims have become perpetrators trying to protect themselves and to cover their own sins.
- 27. My plight is very similar to Lt. General Michael Flynn, Rick Gates, Paul Manafort, George Papadopoulos, and Roger Stone. I have personally come to understand the meaning of Lindsey Graham's opening statement at the IG hearing on the FISA report December 10, 2019. "...its Trump today, it could be you or me tomorrow, and imagine, ladies and gentlemen, if they can do this to the candidate for the President of the United States, what could they do to you?"
- 28. Upon proper request, I will provide the names of the "author," "victim," and her "new husband" along with copies of the briefs and supporting records that prove these claims and the attached Video, Victim, and Witnesses Statement.
